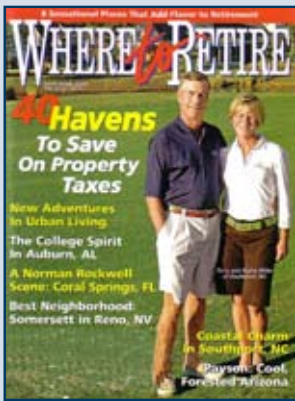
RETIRE TENNESSEE ANNUAL MEETING

The Retire Tennessee communities are from West Tennessee: Hardin County and Henry County; from Middle Tennessee: Cumberland County, Lincoln County, and Putnam County; and from East Tennessee: Greene County, Hamilton County, Jefferson County, and Sullivan County. Retire Tennessee is an initiative developed by the Community Development Division of the Tennessee Department of Economic and Community Development.

Outside of the three cities, Cumberland County has designated about 90% of the sales tax to the school district and one half cent (the sales tax increase of 1999) to debt retirement on new school classroom construction. The remaining portion of the county share of sales tax is about 10%. It goes to the county general fund.
